We are proposing to remove CJ 7300 (Professional Responsibilities in Community Relations, which is known as Ethics for Cops) because we already have Ethical Issues in Criminal Justice which is a requirement for all graduate students in the master's program. Therefore, CJ7300 is no longer needed.

The master's Program in Criminal Justice was reconstituted as part of the 4+1 Program open only to those students in the 4+1 police program. We have created a second concentration called Professional Studies which is available to anyone inside and outside of Fitchburg State.

We are looking to make available a third concentration, Community Justice Concentration, that will go through Graduate Council in the spring. This will also be available to any interested party inside and outside of Fitchburg State. What we are doing now is taking a look at our classes and offering them to anyone interested in any area of the criminal justice system.

Questions/Comments:

Is it the intention to open the course to anyone interested even if they are not a CJ major? Dr. Weiss responded with <u>if</u> a student wants to take the class we would not turn them away.

Is there a reason for replacing the 7000-level course with an 8000-level course? Dr. Weiss responded with the master's program was offered decades ago and the CJ program was instructed by the state to focus on our undergraduate certification. The master's program was always on the books but not offered in quite some time. We decided to use the classes that were already on the books rather than creating a third ethics class.

Are there pre-requisites for this course? Dr. Weiss responded with there are no pre-requisites for this course but there are required courses that need to be taken.
