We would note that the IDIS major is unlike any other major on campus in a number of important ways:

- It is an individualized major, in which a student constructs a plan with an advisor that involves two or three different disciplinary fields, one of which must be an approved minor at the college. Thus, most of the coursework in any student's program of study is done in those disciplinary fields, rather than in the common IDIS courses.
- A shared IDIS core of 15 credits is the only constant in the various possible disciplinary combinations that students can select, and only 9 of those credits are in the three specifically required classes: IDIS 1600, 3004, and 4004.
- The major is designed so that many students who switch into the IDIS major with as many as 90 credits completed and only two semesters left until graduation can still graduate on time without exceeding 120 credits total. The only sequenced element in the major is that IDIS 3004 is the prerequisite for IDIS 4004, so the two sequential fourth-year classes together form the capstone experience.

• A notable percentage of IDIS majors adopt the major as a major of last resort, when they have not been able to meet the requirements to progress in the major that they began when coming to Fitchburg State. Thus, a disproportionate number of our students have shown distinct challenges with their academic performance.

Because of the unique aspects of the major described above, this sort of traditional assessment process alone is not sufficient to guide decision-making about any possible changes that may need to be considered, although it does provide important feedback about how students are able to synthesize their academic experience in a well-developed capstone project.

2024-25 Assessment:

This particular PLO has not been assessed for over 5 years, given that our departmental program review in 2021-22 paused our assessment cycle, and therefore the Humanities Assessment Committee had a two-fold goal this year: firstly, to review our rubric based on the outcome and assess whether the outcome accurately reflected the role of the course in the IDIS program core requirements; secondly, to assess the student work in relation to the revised outcomes.

With respect to our first goal, the assessment committee met prior to assessing the student products to discuss PLOs 1 & 2 and their associated rubrics, and we made some changes to the placement of specific elements to better align the skills in the PLOs with the appropriate student product. The PLOs as originally stated are above in sections A.I.1 and A.I.2., and our rewording of the outcomes is as follows:

PLO A.I.1. - Student Product: Capstone Project Proposal (IDIS 3004)

Students will be able to identify and define a problem or issue which can be addressed from a variety of disciplinary perspectives, by doing the following:

- Define the problem or state the research question
- Justify using an interdisciplinary approach by analyzing and evaluating disciplinary insights into the problem
- Clearly identify the relevant disciplines
- Create a research proposal

PLO A.I.2 – Student Product: Capstone Annotated Bibliography (IDIS 3004)

Students will be able to conduct research in order to construct original interdisciplinary research

questions/problems, and develop well documented, supported, reasoned, and informed conclusions to problems and issues, by doing the following:

- Conduct a literature search
- Create an annotated bibliography with well-chosen and properly cited sources, which identifies the perspective from which each source is written

These edits to the skills listed under each PLO emphasize that articulating the interdisciplinary approach to a specific research question should properly fall under the Capstone Research Project Proposal, rather than under the Annotated Bibliography.

*Targets - We find that it is challenging to set meaningful and achievable targets for the program overall in relation to IDIS 3004, when students transferring into the IDIS program can take IDIS 3004 as their first specifically interdisciplinary course in the program, and are thus being introduced to interdisciplinary research strategies for the first time here. We'd **like** to see 100% sufficient and 50% proficient, but we are looking at work by many students who are being introduced to these skills in this class, so it is to be expected that a higher number are in need of improvement. Nonetheless, the results discussed below are quite disappointing and clearly point to the need for follow-up discussions about how best to foster the outcome goals of the program. However, we would also note that assessment outcomes for the Capstone project itself, which is completed in IDIS 4004 following this work from IDIS 3004, have been much more positive, so it is possible that the trajectory of outcomes over the two successive courses is more positive than what we see here from the first course alone.

Here below are the results of our annual assessment in table form. As noted above, the results are disappointing, and are particularly weak in their inability to clearly articulate the rationale for an interdisciplinary approach to a research question. The research questions that students created are at least adequate in themselves, but the projects generally fail to clearly state how the research question is approached using different disciplinary lenses, with close to 80% needing improvement in the following skills within the outcome: justify using an interdisciplinary approach by analyzing and evaluating disciplinary insights into the problem; clearly identify the relevant disciplines

What changes have been made as a result of using the data/evidence? (close the loop)	We have already mentioned the changes to how the PLO skills are distributed and articulated. Beyond that, since this was the first departmental assessment of this particular PLO using artifacts from IDIS 3004 in over 5 years, we have a number of goals for follow up: 1. We need to work with faculty teaching the course to create a better system to capture all of the student projects submitted in IDIS 3004. As it was, one of the faculty members had bibliographies submitted though an online form in their section, most of which were not recoverable for assessment purposes. Since the proposal and bibliography are intended as paired products in the initial design of a research question and plan, it only made

- sense to us to review student work where both products were available for a given student, which further limited the number of products from an already small poll.
- 2. There is a need for members of the assessment committee to meet with faculty teaching IDIS 3004 to discuss possible strategies within the course to emphasize the importance of identifying disciplinary methodologies, and clarifying the role of each in addressing a research question.
- 3. There is also a need for discussion within the department about how the IDIS program as a whole can foster interdisciplinary habits of mind, in spite of the structural challenges to what is frequently a short timeline with little opportunity for longitudinal development of skills due to students transferring to the IDIS major late in their college careers.
