# **Proposals to Recommend for Approval**

AUC 1: Academic Calendars: 2024-2025 and 2025-2026

Sponsor gave the process of how calendars are put through to the AUC committee and the MSCA contractual background. And that these calendars went through to all subcommittees with no friendly amendments.

- The only change in the 2024-2025 calendar from last year's approval, is that the word Web4 has been changed to College Schedular (Fall 2024: 9/12 & 9/19 and Spring 2025: 1/23 & 1/29).
- There are reading days in each semester (between the last class and final exams).
- (Labor Day, Development Day, President's Welcome, residence halls open) In each year they will have their own day compared to previous years.
- What we're trying to do is create a regular pattern of when things happen from one year to the next, so calendar inceptions will be by formula when creating new calendars. This also depends on when Labor Day falls, etc. and we have to have certain number days (Per the MSCA contract) and Winter Commencement is always on a Friday.
- Committee member stated that they think that Spring break is a week too early. Another committee member agreed. Sponsor answered that part of the thinking is to have semesters divided by half and have it on the second Tuesday of that month. It is also connected to class withdrawals, advising, and class registrations etc.
- Student representative did not have a problem with where spring break has been and in the new calendars being put forth.

### **AUC 2: Changes to Honors GPA Requirements**

A student representative asked the sponsor why the GPA requirement is so low? Sponsor stated it was set by the Board of Higher Education, and also that there are national honors societies that have a GPA requirement of 3.2 as well.
