Discussion regarding whether or not a course can request both CCTAD and AIA outcomes. The LAS revision aimed to address the problem of a 'flat' curriculum by developing a vertical structure with several layers (foundations at the bottom, CCTAD in the middle, and AIA at the top), so allowing a course to have both designations seems to go against this goal. Another concern is the creation of supercourses – so even if a course only satisfies a single outcome for a student, it may still get higher enrollments at the expense of others by virtue of having multiple outcomes. Finally, there is concern about the degree to which a course can truly achieve the teaching of multiple outcomes if there are more than two – the outcomes might be 'diluted' by having so many.

On the other hand, it was pointed out that the committee may not want to 'close the door' on courses whose sponsors demonstrate that they satisfactorily meet multiple outcomes.

Since AUC60 appears to allow for both CCTAD and AIA designations, even if that was not the intent, the subcommittee will discuss at a later meeting whether or not to submit an AUC proposal to clarify this ambiguity.
