CJ7500 Criminal Justice MPTC Practicum

<u>COURSE DESCRIPTION</u>: This course will be taken by all Criminal Justice students who have completed the undergraduate MPTC Police Academy Concentration and who intend to complete the Graduate CJ MPTC Concentration portion of the program. This course will also provide the student the experience necessary for professional development in the policing field.

The Practicum will consist of the field work necessary for completion of the MPTC program and will be conducted under the supervision of MPTC Certified Instructors and FSU faculty members.

This is a twelve credit Practicum.

The Practicum will involve the following field work sessions:

Defense Tactics Training Water Safety **Emergency** Driving Highway Safety (Radar, Breath test, Field Sobriety, Occupant Protection, Crash Investigation) Firearms Less Lethal Applied Semintion Training Patrol Response/Applied Patrol Procedures (includes Motor Vehicle Stops and Arrest/Processing) Active Shooter First Aid/CPR Hazardous Material Response Health and Wellness Domestic Violence and Elder Abuse Response to Person with Mental Illness Sex Crimes Investigation Suicide Prevention

COURSE OBJECTIVES:

At the end of this Practicum students should have achieved knowledge and proficiency in the following areas which will be demonstrated through both actual hands-on assessment testing and through objective based assessment tests.

- Understanding of the principles of Defensive Tactics and less than lethal weapons;
- Water safety
- Emergency Driving
- Highway Safety (Radar, Breath test, Field Sobriety, Occupant Protection, Crash Investigation)
- Firearms
- Less Lethal Applied Semintion Training
- Patrol Response/Applied Patrol Procedures (includes Motor Vehicle Stops and Arrest/Processing)
- Active Shooter
- First Aid/CPR
- Hazardous Material Response
- Health and Wellness (Physical Fitness, Nutrition, Stress Reduction)
- Domestic Violence and Elder Abuse
- Response to Person with Mental Illness
- Sex Crimes Investigation
- Suicide Prevention

SPECIAL INSTRUCTIONS AND GUIDELINES

Students will receive specialized instructions, including Safety Guidelines and Rules which **must** be followed, for the Practicum Sections specified. Fail to follow Safety rules may be result in dismissal from that portion of the Practicum and possibly the Course itself.

Attendance is required at all Practicum sections and sessions as successful completion of each Section is required for MPTC Certification. Excused absence may be granted for documented injury and illness, or for issues such as death in family. Note that missed work must be made up as no grades will be issued for Sections not completed.

COURSE REQUIREMENTS AND DEMONSTRATION OF LEARNING OBJECTIVES

Students will complete the field work sessions listed above under the direction of the FSU/MPTC Police Academy Director, the CJ 4 + 1 Graduate Program Coordinator and/or the FSU Police Concentration Program Academic Coordinator.

Testing in each of the below areas will be conducted by the Section Instructors with Pass/Fail grades issued for the practical skill set work and there will be written examinations in conjunction with each of the specific Practicum section and these will be graded accordingly with a minimum 70 % required to pass. Please note that students must pass all sections in order to be certified by the MPTC.

Complete directions and guidelines will be found on Blackboard and will be discussed by the Instructor/s.

ACADEMIC INTEGRITY

The University and the Instructor expect all students to maintain high standards of academic honesty and integrity. Plagiarism is defined as the use of any other person's work or ideas as your own without giving proper credit. Please see the following from the FSU website regarding academic integrity:

A student's name on any written or creative exercise (e.g., examination, report, thesis, theme, laboratory report, computer program, artistic production, etc.), or in association with an oral presentation, declares that the work is the result of that student's own thought and study. Any work that the student declares as his or her own shall be stated in the student's own words and produced without the assistance of others. Students must make clear through accurate citations when they make use of other sources. Talking during an examination, or possession or use of unauthorized materials or equipment during an examination constitutes an infringement of the academic integrity policy. "Academic integrity is central to the mission of educational excellence at Fitchburg State College. Each student is expected to turn in work completed independently, except when assignments specifically authorize collaborative effort. It is not acceptable to use the words or ideas of another person--be it a world-class philosopher or your lab partner--without proper acknowledgement of that source. This means that you must use footnotes and quotation marks to indicate the source of any phrases, sentences, paragraphs or ideas found in published volumes, on the internet, or created by another student."

ELECTRONICS POLICY: The classroom is a learning environment and an atmosphere conducive to learning must be maintained. To that end, use of electronic media in the classroom is prohibited. Electronic media is defined as cell phones, Blackberries, IPods, Iphones, MP# players or any other similar type of device. Students found using these devices in the classroom will be asked to turn them off. Repeated violations may result in the student being asked to leave the classroom.

Use of laptop computers in the classroom may be allowed with permission of the Instructor. However, students found to be serving the Net, viewing objectionable material (obscene material, violent material, racist/sexist, etc.) or disrupting the class in their use will be asked to turn them off.

<u>Classroom Decorum</u>: It is expected that students will not disrupt class in any way such as by talking or horseplay with other students. Students who come to class late are expected to come in quietly and not disrupt others.

Learning comes from open questions and discussion, and by listening to the points of view of others. Students are expected to participate in class discussions and interaction between the students, the instructor, and other students is encouraged. The opinions of others should be respected. While open discussion is encouraged, the disruption of class is not.

Obscene/pornographic language of any kind, unless used for legitimate academic purpose will not be allowed in the classroom. Derogatory and/or demeaning language directed towards any person or class of persons will not be tolerated and may result in dismissal from the classroom and may be reported to the appropriate office for action. This includes, but is not limited to, language that is considered sexist, racist, bigoted or biased in any way. Respect for persons will be the rule at all times in the classroom.
