Rationale and expected outcomes of course change

Title request was initiated by Dr. Elaine Francis, former Graduate Chair of the M.Ed. in Curriculum and Teaching program. This course is the second part of a culminating experience for candidates in the Brine M.Ed. in Curriculum and Teaching program. In this course the theme of teacher as leader provides a context in which advanced content knowledge and pedagogical theory and practice are integrated and applied as it relates to teacher leadership. The course includes individual presentations of the candidates' Capstone experiences which grew out of their advanced research on a content topic specific to their level and field of certification. This course includes a capstone experience rather than an action research experience, thus the request for the title change was initiated so as to accurately reflect the content of the course.
