# b. AUC #3: Cybersecurity Concentration for CS Majors

## Summary:

The purpose is to create a new cybersecurity concentration in the Computer Science major similar to the cybersecurity concentration in the Computer Information Systems major. We have the courses and they are popular with computer science students, so we want the CS majors who have been taking the relevant courses to benefit from this concentration.

## Discussion:

Q: Only change is cybersecurity electives instead of 5 CS electives? yes

Q: Will the lab requirement be set at 3 credits? A: This will probably be the case for the CS program as a whole, but this has not happened yet.

Q: When with this change (3-credit labs) happen? A: This is dependent on hiring, which so far has not been approved by Admin. Proposal will maybe be submitted early next semester.

Q: What kind of demand is there for this concentration? A: We don't have a specific count, but a significant number of students are interested. There probably won't be a need for new sections unless numbers go up.

Q: What distinguishes this from the cybersecurity concentration in the Computer Information Systems major? A: It will now be attached to the CS major.

## c. AUC#4: Request for MAJ Designation for CJ Courses

Our four CJ Internship Seminar courses were "cleaned up" and we are requesting the MAJ to count for the AIA/IHIP requirement. Students can complete a 3, 6, 9 or 12 credit internship. Only 3 of these credits would count toward Gen. Ed. AIA and IHIP.

## Discussion:

Q: Will this count for AIA or IHIP? A: Both, but just IHIP if push comes to shove.

Q: Barbara Cormier (Reg) notes: this will need to be a manual process, not an automatic one, because of the programing.

DW asks: what is needed? BC: Registrar will need list of students so that it can be added manually.

Q; How many students are doing internships? A: It varies, but most do them in spring. As of now (for spring), there are 24. In the fall, usually fewer than 10, summer, 10-12.

Q: IHIP w/o AIA? A: Kisha notes: all IHIPs are AIA, but not other way around.
