e. AUC #30: U.S. Military History Sean C. Goodlett

- A summary was given by Sean Goodlett as an overview of the proposed course as a survey of
 military history from the colonial era to the modern war on terror. Sean explained that this is a
 survey of United States Military History, substantiating U.S. American military power in a world
 context. It is a history survey and serves ROTC Cadet pre commissioning requirements to
 become a Second Lieutenant for the U.S. Army.
- Discussion regarding level of the course Q: is the course a 1000-level or 3000-level course. There are some places in the proposal where there is mention of 1000-level course. It was noted that the only mention of 1000-level course is in the Gen. Ed. designation. Clarified that proposal is for 3000 level. Question about why a 3000 level course with no prerequisites. A: This will be consistent with how HIST courses are numbered. Q: would you consider giving it a junior-level standing. A: We are trying to make available to as many students as possible. Any ROTC students would be able to take this as their HI Gen Ed. class. Comment (Staab): communications media uses numbers for different parts of their curriculum, not for level of class.

- Sgt. Maj. Darryl Gill (Ret), who teaches a similar course at other institutions, also spoke in favor of the proposal. He said that ROTC students in this region currently take this course at other institutions.
- Concerns were raised by some of the historians in the department that they were not brought into earlier conversations about this course, that the training on military history should not be required to teach the course and that ROTC students should have other options for history courses that include military history, as is the practice at some institutions. They do not support the addition of this course in its current iteration. It was noted that, in addition to the department's curriculum committee, the full department later voted in favor of this proposal but with votes that indicated opposition in the department.
