Graduate Assistantship Opportunity 2017-2018

This Assistantship provides support for the Division of Education, specifically in the area of Accountability and Data Management. Eligible candidates must be matriculated into a Fitchburg State graduate program. Examples of primary responsibilities include assisting in the preparation of Division accreditation reports, activities, projects, and events; attendance at Division and Standard meetings, assisting in the preparation and maintenance of Department of Elementary and Secondary Education candidate licensure records; assisting with Tk20 Assessment system maintenance. Required skills include punctuality and dependability; ability to maintain confidentiality; technology competence in Word, Excel, PowerPoint and other web-based systems; excellent and professional command of Standard English Conventions, oral and written; a pleasant and professional demeanor; and ability to work independently. Graduate Assistants receive tuition and fee remission for 15 credits and a stipend of \$8,800 for the academic year beginning September 2017 and ending June 30, 2018. Practicum Application Information—Fall 2017

Even if you have an MTEL pending, you must submit an **Application for Graduate Practicum NO LATER THAN May 1**, **2017** for fall practicum. *If you are needing a placement, please submit your application as soon as possible.* If you are employed at your practicum site, you must secure an on-site mentor/supervisor. Eligible mentors/school supervisors hold an initial or professional license in the area of licensure that you seek, have taught under the initial license for at least 3 years, and have been rated proficient or higher on the Educator Evaluation System.

Applicants for Graduate Practicum must meet with their program advisor for a Stage Two Review to confirm eligibility for practicum. **Stage Reviews are due to the Field Placement Coordinator no later than May 1, 2017**.

A Fingerprint as well as a CORI background check are now required for practicum candidates in the Commonwealth schools.
