to
Early Childhood Education – Early Education and Care
Bachelor of Science in Education

Purpose


This agreement is set forth by Quinsigamond Community College and Fitchburg State University in an effort to delineate a transfer student's best options in course selection. This document signifies the ongoing commitment between these institutions of higher learning to promote coordinated curricula of the highest quality. As such, it bears with it the commitment of our respective faculty, and administrative staff to strengthen these ties and address the needs of our students in a mutually beneficial manner.

Terms and Conditions of Transfer


- A. Students graduating from the Quinsigamond Community College Early Childhood Education (EC) and Early Childhood Education – Birth through Eight Years Old Option (ECBA) Associate Degree programs, with a qualitative grade point average of 2.0 or greater, and upon completion of Fitchburg State University's admissions requirements, are guaranteed acceptance.
- B. In addition, 62-75 credits of the completed QCC Early Childhood Education (EC) and Early Childhood Education – Birth through Eight Years Old Option (ECBA) degree will be accepted and applied to Fitchburg State University's Early Childhood Education program.
- C. Students graduating from Quinsigamond Community College's Early Childhood Education (EC and ECBA) degrees whose transcripts are marked as completing the MassTransfer Block (or General Education Foundation) will receive benefits through MassTransfer. This includes guaranteed transfer of at least 60 credits and waiver of general education requirements. Eligible students who graduate with a 3.0 or higher GPA may receive a tuition waiver for their state-supported (day) courses.
- D. Quinsigamond students will be advised to complete the prescribed coursework, and electives as listed in the attached program grids. Failure to follow these recommendations will result in additional coursework requirements and longer time to degree completion at Fitchburg State.
- E. Acknowledging that students may, and do transfer from a wide variety of majors, this agreement does not prohibit transfer to or from other programs of study at either institution. This agreement suggests optimal transfer routes from Quinsigamond Community College to Fitchburg State University.

This agreement becomes effective as of July 1, 2022 and will remain in effect through July 1, 2025 with the provision that the terms specified herein will continue to apply to graduates who transfer from Quinsigamond Community College to Fitchburg State within one year of the expiration of this agreement. The faculty at both institutions agrees to meet annually to review the agreement and discuss modifications.







ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO Quinsigamond Community College (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
